



Professional Certification Education Points Scheme

Please Note:

Evidence must be provided for all claims for points (eg Attendance Certificate, Registration Flyer, etc).

Relevant educational activities and memberships includes any activity which fulfils the mission of the Australian Organisation for Quality (AOQ) "to improve the competitiveness and sustainability of Australian businesses."

Points will be allocated according to the following formula:

AOQ Educational Activities:	1 point per hour attended 5 points per hour presented.
Other Educational Activities (Reviewed):	1 point per hour attended 5 points per hour presented.

Employment:	10 points/EFT year (pro-rata for P/T)
Membership of AOQ:	5 points/year
Professional Member of AOQ:	10 points/year
Membership of other relevant Associations:	3 points/year
Professional Membership of other relevant Associations:	6 points/year
President/Chairman/President-Elect (not Vice President) Branch	25 points per year
President/Chairman/President-Elect – National	35 points per year
Chairman of Division	15 points per year
Council Membership (State, National and Divisions):	10 points/year each (not counted for President/Chairman/President-Elect)

5 points/per presentation

Presentation of Poster at Qualcon:

5 points/per presentation

Publication of Paper in Refereed Journal:

20 points if primary author

10 points if secondary author

Publication of Paper in Quality Australia:

10 points/per publication

Publication of Paper in non-refereed Journal:

5 points/per publication

* These are for quality and management related courses. For Certification only the points for the highest qualification in any field may be counted.

Requirements for Certification:

Initial Certification - Fellow:

200 Points

Initial Certification – Executive

150 Points

Initial Certification – Advanced

120 Points

Ongoing Certification:

100 Points in every two-year period
